# Legislature leaves **WITHOUT PASSING** additional raises, bonuses

The General Assembly adjourned in the last week of June without passing an amended budget with additional raises or bonuses for state employees or retirees.

Legislators did formally authorize the 3% raises already budgeted, which took effect on July 1.

Before leaving, both the House and Senate passed their own proposals. The House plan included an additional 1% raise for a total of 4% for most state employees and a 2% one-time bonus for retirees. It also includes a raise of 8% for step-pay plan employees, including Correctional Officers, Probation/Parole Officers, and Juvenile Justice employees.

The Senate's version was much smaller and dealt mostly with school voucher expansion. It included no additional money for employees or retirees.

Lawmakers are expected to return in the fall and could reach a compromise on additional spending for raises or bonuses.

#### **STATE HEALTH PLAN BOARD**

The end of the session wasn't without a few fireworks. In the closing days, SEANC's lobbyists pressed lawmakers to step in to protect employees' voice on the State Health Plan Board of Trustees. Gov. Roy Cooper appointed an exempt employee who is an agency Deputy Director to replace Wayne Fish, a former SEANC president and employee at Craggy Correctional, on the board.

This means there are no rank-and-file employees or teachers on the board now, and you have no voice in decisions on drug coverage, premiums, or any other matters related to the plan.

Thank you to the many members who

acted when we called on you to contact your legislators regarding this issue. Unfortunately, lawmakers left town without addressing our concerns. We plan to continue to work with them on this problem.

#### TAX CAP AMENDMENT

An attempt to put a constitutional amendment on the ballot to cap the state income tax rate at 5% failed to get enough support in the House. SEANC opposed this because we are already concerned about the state's ability to adequately fund salaries and public services. This amendment is an unnecessary constraint to the state's ability to tackle the vacancy crisis.

"It's kind of a public statement of what their priorities are, or priorities are not. We're still facing a vacancy crisis. It hasn't gotten any worse, but it certainly hasn't gotten any better. And, in order to retain the good people we've got and potentially recruit new people, it comes down to the money."

# SEANC leading the fight for affordable prescription drugs

SEANC's fight to cut outrageous prices on prescription drugs like Wegovy and Ozempic made national headlines and spurred action in high places!

SEANC President Kirk Montgomery spoke in April at the State Health Plan Board of Trustees meeting about the need to focus on lowering the cost of these drugs so plan members can afford them.

Montgomery, his wife Pam, and Executive Director Ardis Watkins met with Sen. Bernie Sanders in April to discuss the issue. Sanders sent a letter to Novo Nordisk's chief executive asking for internal communications on pricing in the United States, which is substantially higher than in the rest of the world.

SEANC District 65 Chairwoman Kiana Price and District 42 member Tralene Williams were featured in a story from USA Today about the impact of the decision to end coverage for these drugs by the State Health Plan,

State Treasurer Dale Folwell also appeared on NBC Nightly News and CNBC to discuss the issue.






