## **UPDATES**

#### **Hurricane Helene Relief Efforts**

Western Region Representative Cliff Johnson and Retiree Council Chairman Jamie Robinson updated the board on SEANC's relief efforts after Hurricane Helene. They reviewed a timeline of SEANC's efforts, which began before the storm left the area.

We activated SEANC Cares to start handing out relief. Johnson and Robinson drove to as many places as possible to assess the needs and make contacts.

Johnson played a video of the massive effort at Black Mountain NeuroMedical Treatment Center to distribute goods to those in need. He also showed pictures from SEANC's distribution at Mountain View Correctional Institution, where First Vice President Wendell Powell made the trip to help out.

Robinson commended the staff, particularly Western Member Relations Rep. Adam Winebarger and Public Education Liaison Brad Langhans, for their hard work in gathering and delivering the goods. Johnson thanked the board for supporting the effort as well.

District 5 Chairman Willie Jobe shared his own experience through the flood. His property received heavy damage, particularly his farming equipment. Several of his neighbors lost their homes and even their lives.

Johnson reminded the board that the relief effort is ongoing. "It's not over. It's a marathon, not a sprint. There will be needs in the area for years to come."

# First Vice President's Report - Wendell Powell

- President Kirk Montgomery had an emergency surgery earlier in the week and is recovering.
- Hurricane Helene relief efforts: We are communicating with our members, other organizations, and state facilities to learn their needs so that SEANC can put together a proper response and provide assistance where needed.
- President Montgomery and Powell joined the lobbying team. They talked to legislators who returned to Raleigh for a disaster relief session in October to discuss their plans to assist state employees and retirees.
- I attended meetings such as the Statewide Membership, One Voice Barriers to Bridge Conference and NC Correctional Association Conference. The planning committee will meet in January via Zoom.

# Second Vice President's Report - Emily Jones

- Jones attended many events throughout the state, including the J. Iverson Recruitment Event, the NCOAC Trunk or Treat Event, and the NCCA Conference.
- During the events, state employees and retirees learned about the importance of SEANC membership, and new members were recruited.
- Jones encouraged everyone to support and participate in legislative events Be the voice for our members.

#### Past President's Report – Martha Fowler

- Fowler attended several meetings and events including Chancellor's Cup Golf Tournament, Membership Committee, Retiree Council, Retirment System Board of Trustees quarterly meeting, NC A&T State University Employee Benefits and Wellness Fair and NC Coalition on Aging.
- She also serves as Officer Liaison for Bylaws Advisory, Growth & Expansion, Investment Advisory, Retiree Council, Scholarship and is Chairwoman of the Past Presidents.

# **Treasurer's Report - Stacie Crabtree**

Crabtree reviewed the final budget for the fiscal year that ended on Sept. 30, 2024.

She attended multiple committee and district meetings since the last BOG meeting.

# **Executive Director's Report - Ardis Watkins**

Watkins reviewed two efforts SEANC has worked with the State Employees Credit Union to help members.

- The State Controller has decided not to pay employees on Dec. 20 this year. SECU has created a loan program to help employees bridge the gap by borrowing up to \$1,000 for a 6-month term at 5.0% APR. Details can be found on the SEANC website and in the SEANC Scoop.
- We also attempted to set up a program for employees to donate funds to other employees affected by Hurricane Helene. SECU and SEANC developed a plan together, but the State Office of Human Resources opposed it, and it did not work out.

Watkins said we are facing the "perfect storm" of heading into the upcoming budget debate.

- Because of the election results, the Presidency and Congress will be of the same party and have already said they will make drastic cuts to spending on everything. Those costs are going to be shifted to the states.
- The legislature just spent \$468 million on vouchers for private schools.
- Hurricane damage is expected to top \$60 billion.
- The State Health Plan is facing an operating funds shortfall over the next three years.

Watkins said the outlook for revenue is dire. We will fight to stop job cuts, especially those positions that are currently unfilled. Pay increases will be difficult this year as well, but we will fight for them as always. She also discussed the new State Treasurer, Brad Briner, who has publicly stated that he thinks retirees are "crowding out other priorities" in the state budget.

Luther Sales has folded after its leader died unexpectedly. SEANC is taking steps to protect our members who have accounts and those who have yet to receive their goods.

- The committee met on September 26, October 31, and November 13. The Subcommittee met on November 7 to develop policies and procedures for districts' use of Square.
- The board approved policy and procedures for district use of Square. All treasurers, secretaries, and district chairpersons will be required to undergo mandatory Square user training.

# **MOTIONS**

- Passed: To approve and accept the Board of Governors' meeting minutes of
  - Wednesday, September 4, 2024
  - Saturday, September 7, 2024
  - Wednesday, October 9, 2024
- Passed: To approve and accept the SEANC Convention Minutes, with revisions, of Thursday, September 5, 2024 Saturday, September 7, 2024.
- Passed: To approve and accept the Treasurer's Report.
- Passed: That the Scholarship Board pay the \$15,000 that is available in the Scholarship funds for the 2019 2021 audit and that the Board of Governors will forgive the remainder of the difference owed to SEANC for the audit. Note that SEANC has already paid the invoice for the Scholarship Audit. This is to address the monies owed to SEANC to reimburse for the Scholarship Audit.
- Passed: That SEANC issue three resolutions to show appreciation for work provided for Hurricane Helene Relief to: (1) Anika Harper, (2) Black Mountain Neoneuroligcal Medical Center, and (3) Mountain View Correction Center.
- Passed: To accept and approve the Square Utilization Policy:
  - A district that is currently more than 60 days delinquent in their monthly financial reporting is not eligible to initiate use of Square for receiving funds.
    - Only those individuals that are bonded with the district may have login access to the Square account.
  - For proper documentation and tracking, districts are required to use the Item Library features to track each type of fundraising activity separately.
    - Districts must opt for the default automatic funds transfer option of 1-2 business days.
  - Two-factor authentication must be used on all electronic devices on which the Square account may be accessed.
    - Users must sign out from Square on all devices when Square is not in use.
- Passed: To change the Executive Director's annual performance timeframe from May 1 April 30 to the SEANC fiscal year (October 1 September 30).
